If using Genome Medical:

- 1 Genome Medical's virtual genetic experts will give you guidance on your testing options via a virtual pre-test consultation, **all from the comfort of your home.**
- 2 Upon completing your pre-test consultation, the genetic counselor will determine your eligibility for the MyRisk™ Hereditary Cancer test. If you meet criteria, a test kit will be sent directly to your home for convenient sample collection.

If using your own provider:

- 1 Take this document along with the **Test Request Form** (included in the test kit) to your appointment to review with your provider.
- 2 If you and your provider decide that MyRisk Hereditary Cancer testing is right for you upon reviewing your assessment results, **your provider will collect a saliva sample and place an order for your test.**

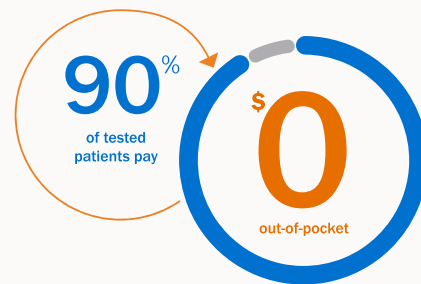
After you submit your sample:

- 3 Once your sample arrives at Myriad, **we will contact you directly with a cost estimate** to process your test (after checking your insurance benefits and/or eligibility). You will receive your cost estimate via email and/or text within a few days. If you are unsatisfied with your estimate, you have the option to cancel your test at no charge; please note that once your test is processed we are unable to cancel.
- 4 Upon completion of processing your sample, **we will send the final report** of your test to your ordering healthcare provider.
- 5 If your insurance assigns patient responsibility for coinsurance or deductible, we will send you an invoice with payment plan options. You may receive an Explanation of Benefits – **this is not a bill.**

More about test costs and coverage

What is the likelihood my testing will be covered?

Most patients have complete coverage for genetic testing. About 95% of private insurers have coverage for testing, and 90% of tested patients pay \$0 out-of-pocket.



What is considered in a cost estimate?

We take into account your insurance plan (if applicable), your remaining deductible, and your financial assistance eligibility.

What if I'm not covered or need financial assistance?

Myriad has options to help patients with any out-of-pocket costs. The Myriad **Financial Assistance Program** offers reduced out-of-pocket costs based on family size and income for qualifying patients. We offer interest-free payments as low as \$15 per month.

Information for your healthcare provider:

Your patient expressed interest in hereditary cancer testing through a Myriad Genetics online assessment.

In completing the assessment your patient was identified as a potential candidate for the **MyRisk™ Hereditary Cancer Test** based on their personal/family cancer history provided.

They have **downloaded the following materials** to help facilitate a discussion with you about the possibility of completing MyRisk™ hereditary cancer testing based on your evaluation and recommendation.

What is the MyRisk™ Hereditary Cancer Test?

MyRisk™ Hereditary Cancer Test combines genetic information along with personal and family history to better assess an individual's cancer risk. It is one of the only clinically actionable tests of its kind, which is why a healthcare provider is required to place the order.



MyRisk™ does not tell you whether someone does or does not have cancer. Rather, it analyzes genes associated with increased hereditary risk for eight different types of cancer. The MyRisk™ test works to determine whether any harmful genetic mutations, which would increase risk for cancer, are present within these genes. This information enables you and your patients to implement risk-reducing actions such as increased screening, preventative medicine, or preventative surgery, when appropriate.



Should you choose to proceed with testing this patient, a saliva sample will be needed.

That sample will then be sent to Myriad Genetics, where we will **process the sample and return the results to you.** Most results are ready within 14-28 days from the time of sample collection.
